The LGU **Manaoag, Pangasinan**, through its **Bids and Awards Committee (BAC)**, invites all interested Phil-GEPS registered suppliers/manufacturers/distributors/contractors/builders/fabricators to apply for eligibility and to bid for the hereunder project:

**Name of Project:** Upgrading of Local Access Road with Stone Masonry

**Location:** Along Mermer – Oraan West Road Network, Barangay Oraan West, Manaoag, Pangasinan

The **Approved Budget for the Contract is Three Million Six Hundred Thirty Six Thousand Pesos (P3, 636,000.00)** and it is under the **AM Fund**. The **contract duration** for the project is **One Hundred Twenty (120) Calendar Days** starting from the date of the **Notice to Proceed**. The **Pre-Bid Conference** will be on **December 16, 2020 at 9:30 AM sharp** at the **Conference Room, Regional Evacuation Center, Barangay Pugaro, Manaoag, Pangasinan**.

The **Bidding Documents** may be acquired by interested Bidders at the **2<sup>nd</sup> Floor MPDC Office, Municipal Hall, Manaoag, Pangasinan** from **December 10, 2020 to December 29, 2020** from **8:00AM to 12:00 NN** and from **1:00PM to 5:00PM, Monday to Friday**, and up to **December 31, 2020, Thursday at 8:00AM only**.

**Deadline for the submission of the Bid/Tender Documents/Forms** is on **December 31, 2020, Thursday at 9:00AM** at **2<sup>nd</sup> Floor, MPDC Office, Municipal Hall, Poblacion, Manaoag, Pangasinan**. The **Opening of Bids** will be held on the same day, **December 31, 2020, Thursday at 10:30 AM sharp** at the **2<sup>nd</sup> Floor Youth and Tourism Building , Barangay Poblacion, Manaoag, Pangasinan**. **Late Bids** will not be accepted.

Prospective bidders should have experience in undertaking a similar project within the last 2 years with an amount of at least 50% of the proposed projects for bidding. The eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary “pass/fail” criteria. Post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre Bidding Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations (IRR).

**Bid Document** will be available only to eligible bidders upon payment of the non-refundable amount of **P2,000.00** to the **Municipal Treasurer’s Office**.

The **LGU- Manaoag, Pangasinan** reserves the right to accept or reject any bid, to annul bidding process and to reject all bids at any time prior to contract award without thereby incurring any liability to the affected bidder or bidders and assumes no responsibility whatsoever to compensate or indemnify bidders incurred in the preparation of the bid.
