2. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act RA 9184.
3. Interested bidders may obtain further information from Municipal Government of Manaoag, Pangasinan and inspect the Bidding Documents at the address given below from April 08, 2024 to April 26, 2024 from 8:00AM to 5:00PM, Monday to Friday & Up to April 29, 2024, 10:00AM only.

A complete set of Bidding Documents may be acquired by interested bidders April 08, 2024 to April 29, 2024 from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of One Thousand Pesos (P1,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person.
5. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before 11:00AM, April 29, 2024. Late bids shall not be accepted.
6. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
7. The Municipal Government of Manaoag, Pangasinan, Bids and Award Committee (BAC) will hold a Pre Bid Conference on April 15, 2024, Monday at 11:00AM at 3rd Floor, BAC Office, BOSS Building, Municipal Hall, Barangay Poblacion, Manaoag, Pangasinan, which shall be open to prospective bidders.
8. The Bid Opening shall be on April 29, 2024, at 11:15A.M., at the 3rd Floor, BAC Office, BOSS Building Municipal Hall, Poblacion, Manaoag, Pangasinan. Bids will be opened in the presence of the bidders’ representative who chooses to attend the activity.

The Municipal Government of Manaoag, Pangasinan reserve the right to reject any and all bids, declare a failure of bidding, or not award the contact at any time prior to contract award in accordance with Section 35.6 and Section 41 of the revised Implementing Rules & Regulations (IRR) of R.A. 9184, without thereby incurring any liability to the affected

bidder or bidders.
